TERMS AND CONDITIONS FOR DISPOSAL OF OLD CONDEMNED UNSERVICEABLE ITEMS

- 1. Interested Parties (Scrap Dealers/Buyers/ Recyclers) may submit their highest prices for the purchase of obsolete and unserviceable items viz., Computers, Printers, UPS with batteries by 5:00 PM on or before 10-08-2022 along with Earnest Money Deposit (EMD) of Rs. 2,000/- in the form of Demand Draft or Banker's Cheque drawn in favour of the Director, NCDIR, and payable at Bengaluru, super scribed as "TENDER FOR DISPOSAL OF CONDEMNED UNSERVICEABLE ITEMS". The cost of tender fee and EMD amount is payable by means of a Demand Draft or Banker's Cheque drawn in favour of Director, ICMR-NCDIR, Bengaluru and payable at Bengaluru. (Payment by Cheque/Cash shall not be accepted).
- 2. ICMR-NCDIR, Bengaluru will not be responsible for delayed / late submission/ receipt of tender sent by post / courier etc.
- 3. Tender received after stipulated date/ time / incomplete and also without tender form fee and EMD amount will not be considered at all by this office.
- 4. Submission of tender: Only physical bids received by ICMR-NCDIR, Bengaluru office will be considered for opening. **Bids sent through fax or email will not be considered.**
- 5. The disposal of condemned unserviceable items shall be strictly on "AS IS WHERE IS BASIS". The condemned unserviceable items can be inspected physically between 10.00 AM and 5.00 PM on any working day between Monday and Friday from 21-07-2022 to 10-08-2022 at ICMR-NCDIR, Bengaluru. The visitors / representatives of the firms / persons are requested to sign in the register after inspection of the items.
- 6. No complaint whatsoever will be entertained after the tender has been submitted or before or after the items are lifted. No request for inspection after submission of tender will be accepted.
- 7. The successful bidder will be required to deposit the total bid amount by means of Demand Draft drawn in favour of Director, ICMR-NCDIR, Bengaluru within three working days of award of contract.
- 8. If the highest qualifying firm fails to accept the bid, their bid will be cancelled and the EMD deposited by such bidder will be forfeited. In such an event, an opportunity will be given to the next highest qualifying eligible tenderer (H-2) at the sole discretion of Director, ICMR-NCDIR. If such second highest bidder also does not honour the bid offer and unilaterally withdraws from the bidding process, after having been decided as the highest bidder, the EMD deposited by him/her will also be forfeited to the ICMR-NCDIR and the bid proceedings initiated under this notification will be considered as null and void.

- 9. EMD of the successful bidder(s) will be released only after realization of sale amount. EMD of the bidders, who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this office. EMD amount will not be adjusted in the Sale Amount. EMD of successful bidder(s) shall be released only after successful completion of the sale process. EMD shall be refunded to the unsuccessful tenderers after finalization of Tender in all respects.
